

## COPEC S.A. Environmental Policy

At Copec, we are defined by our commitment to Chile, which we declare in our corporate purpose: “We exist to empower the development and mobility of people, companies, and the country” through products, services, solutions, and experiences that meet the needs of a life in motion. We do this with excellence, minimizing the environmental impact of our processes and seeking a balance between economic profit and the value we bring to society.

This Environmental Policy applies to Copec S.A.'s own operations. In this regard, at Copec we are committed to:

- Protect the environment by identifying and controlling the environmental aspects and impacts related to our operations, applying a life cycle approach. In addition, assess the risks and opportunities related to our environmental management, ensuring the timely implementation of actions that prevent and mitigate possible impacts.
- Establish and execute the necessary processes to address any situation of risk or potential environmental damage in our operations, always acting in an ethical, responsible, and diligent way. This includes mitigating and repairing any environmental damage under our responsibility, as well as implementing measures that minimize the likelihood of recurrence, in accordance with our Code of Ethics.
- Identify and comply with current legal and regulatory requirements applicable to our activities, as well as environmental commitments made to the relevant authorities and the communities with which we relate. Similarly, consider relevant environmental variables from the initial stages of new projects, adopting a preventive approach that contributes to reducing the possible negative impacts of our operations on the environment.
- Promote the creation of environmental value for the organization and its stakeholders, encouraging the implementation and compliance with the guidelines established in this policy, and fostering an organizational culture committed to environmental protection and individual environmental responsibility.
- Encourage continuous improvement of our environmental performance by establishing environmental goals and targets aligned with the corporate strategy.

Copec is committed to protecting the environment and integrating sustainability into all its activities and its value chain. In line with its Climate Change Statement, Sustainability Policy, Zero Waste Policy, and Energy Policy, the company seeks to play a leading role in the global transition towards a more sustainable, circular, and decarbonized economic development model, considering the needs of society and prioritizing a balance between the environmental, social, and economic impact of its activities.

In accordance with the above, in recent years Copec has taken significant steps to transform its business model, establishing ambitious guidelines and carrying out specific actions aimed at

improving its environmental performance, which is why the following strategic guidelines have been established:

- Promote the energy transition by significantly increasing the use of renewable energies, developing new energy capabilities, and promoting sustainable mobility as alternatives to mitigate the consequences of climate change by reducing greenhouse gas (GHG) emissions.
- Improve comprehensive waste management, moving towards more sustainable practices and enabling the transition to a circular economy model, with the aim of reducing waste generation.
- Encourage the reduction and responsible use of natural resources, including water, energy, and raw materials, continuously seeking efficiency in processes and the adoption of more sustainable technologies.
- Support research and development of new technologies that contribute to climate change mitigation and more sustainable environmental management.
- Promote staff awareness of the impacts of our operations on the environment and the role of each employee in protecting it.

This policy has been approved by Copec's CEO, and its implementation and monitoring are overseen by the Sustainability Committee, the body responsible for ensuring compliance, periodic review, and continuous improvement.
